SUBJECT: Annual Report of the Client Security Fund Committee

Pursuant to Practice Book § 2-73 (a), the following is a report of claims filed with the Client Security Fund Committee during calendar year 2020, and on the committee's activities during 2020 in connection with claims filed with the committee.

## **I. Claims Filed**

During 2020, seventy-six (76) claims for reimbursement were filed with the Client Security Fund Committee. By comparison, eighty (80) claims were filed in 2019. The total dollar amount of claims for reimbursement filed with the fund during 2020 was \$3,444,501.46 as compared with \$2,203,391.16 in claims filed during 2019.

## **II. Activity on Claims**

During 2020, the Client Security Fund Committee approved payments to claimants in twenty-nine (29) claims filed with the committee. The total dollar amount of reimbursement approved during 2020 was \$739,370.73. By comparison, sixty-four (64) claims were approved for reimbursement during 2019, with a total amount of reimbursement approved of \$4,992,158.74. A list of the names of attorneys whose conduct resulted in awards of reimbursement during 2020, and the amounts awarded, is attached hereto. Thirty-eight (38) claims were also denied during 2020.



At the end of calendar year 2020, eighty-four (84) claims remained pending in the total amount of \$4,287,827.90, as compared with seventy-five (75) claims pending at the end of calendar year 2019 in the amount of \$2,252,191.70. The balance available in the client security fund at the end of 2020 was \$10,647,562.11.
