1. To hear the Report of the Secretary.
2. To hear the Report of the Treasurer.
3. To hear the Report of the Chair concerning a letter dated September 5, 2007, from the President and Dean of the Concord Law School, a non-ABA accredited law school located in Los Angeles, California, and to take such action thereon as the Committee deems appropriate.
4. To hear the Report of the Chair concerning a letter addressed to Hon. Peter T. Zarilla, Chair of the Rules Committee of the Superior Court, dated August 27, 2007, and signed by the deans of the three resident and ABA approved law schools located in the State of Connecticut, concerning an amendment to Rules of Practice, chapter 2, and proposing a Rule designated Sec. 2-13A, as to the practice of law in Connecticut by various law school personnel, not otherwise admitted in Connecticut. The proposal contemplates various administrative action by the CBEC and by the various Standing Committees.
5. To hear the Report of the Chair concerning the results of the mail vote and the present status of the proposed Regulations and the various application forms with respect to the administration of the In-House Counsel Rules change, and to take such action thereon as the Committee may deem appropriate.
6. To hear the Report of the Chair concerning pending litigation, and to take such action thereon as the Committee may deem appropriate.
7. To hear the Report of the Subcommittee on the use of computers in connection with Bar examination, and to take such action as the Committee may deem appropriate.

8. To hear the Report of Mr. Whelton concerning various character and fitness matters, and to take such action thereon as the Committee may deem appropriate.
9. To hear the Report of Judge Quinn concerning applicants with degrees from foreign law schools, and to take such action thereon as the Committee may deem appropriate.
