### I. OLD BUSINESS

C.) Client Security Fund Committee Office Staff

D.) Client Security Fund Committee Non-Attorney Member Vacancy

Judge Bright reported that due to a recent resignation there is presently a vacancy for a non-attorney member on the committee.
