

On Monday, May 9, 2022, the Rules Committee of the Superior Court conducted a public hearing using *Microsoft Teams* to receive comments concerning proposed revisions to the Practice Book and, pursuant to subsection (c) of Section 51-14 of the Connecticut General Statutes, to receive comments on any proposed new rule or change in existing rule that any member of the bar or the public deemed desirable. At the conclusion of the public hearing, the Rules Committee met using *Microsoft Teams* from 10:05 a.m. to 10:11 a.m.

Judges Alex V. Hernandez and Sheila M. Prats were unable to attend. Also in attendance were Joseph J. Del Ciampo, Counsel to the Rules Committee, and Lori Petruzzelli, Assistant Counsel to the Rules Committee.

1. The Committee approved the minutes of the meeting held on March 14, 2022, with a correction to form number JD-CL-143 in numbered paragraph two on page one. Judge Aberly-Wetstone abstained.

2. The Committee considered a proposal from legal services associations to amend Practice Book Sections 7-10 and 7-11 and to adopt new Section 7-11A regarding retention and destruction of summary process records (RC ID # 2021-023).

After discussion, the Committee tabled this matter to September and requested that Counsel obtain information on why S.B. 200 did not pass in the Senate.

3. The Committee considered the proposed schedule of Rules Committee meetings for 2022/2023.

After discussion, the Committee unanimously approved the following schedule of meetings, subject to future amendment:

4. Counsel noted one amendment was required to the revisions being considered by the Committee to Section 2-16.

The Committee voted unanimously to modify language in Section 2-16 to delete “Statewide Grievance Committee” in the third to last sentence of that section.

5. The Committee voted unanimously to submit to the judges for a vote on adoption all rules changes recommended by the Committee.
