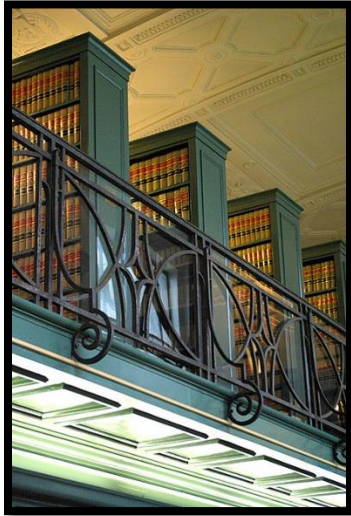


CT Supreme Court 2nd Term Case Advisory, Oct. 28-Nov 7, 2024

The [Connecticut Supreme Court's](#) second term of the 2024-2025 court year begins on Monday, Oct. 28, and ends on Thursday, Nov. 7.
