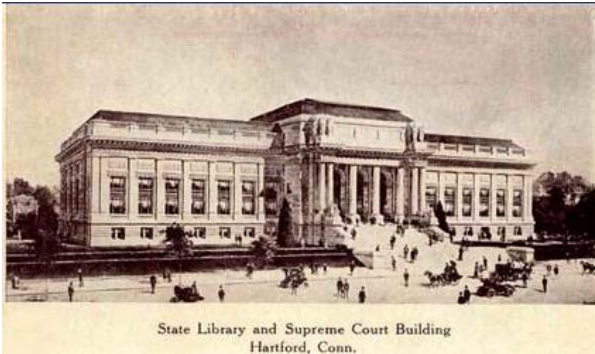


CT Supreme Court Fifth Term Case Advisory
