Instructions

1. Only use this form to ask the court to erase convictions for offenses committed **before** January 1, 2000 that are eligible for erasure under Clean Slate.
2. Complete the form, swear to the contents, and sign it before a Notary Public, Commissioner of the Superior Court, Clerk, or other proper officer.
3. File the form in the court location where you were sentenced for the crime that you are asking the court to erase. If you were sentenced in a court that has since closed, see the chart on the back of this form to find where you should file your petition.
4. If you have crimes from more than 1 case, you **must** file a **separate form** for each case. The court **cannot** process forms with crimes from more than 1 case on the form.

Crime(s) defendant asks the court to erase

Petition for Clean Slate erasure

I, the defendant named above, state under oath that:

1. The crime(s) listed above:

- a. Happened before January 1, 2000.
- b. Are allowed to be erased because they are:
 - Misdemeanors
 - Class D or Class E felonies
 - Unclassified felonies for which the court could sentence me to no more than 5 years by statute; or
 - Motor vehicle violations for which the court could sentence me to no more than 5 years by statute

NOTE: If you were convicted of a crime for which the court could have sentenced you to more than 5 years by statute, that crime is **not** eligible for erasure, even if the court sentenced you to 5 years or less for that crime.

- c. Are **not** blocked from erasure.

NOTE: Crimes that are blocked from erasure include:

- A violation of General Statutes § 14-227a if you were convicted of another violation of § 14-227a within 10 years of your conviction.
- Sexually violent crimes
- Nonviolent sexual crimes
- Crimes listed in General Statutes § 54-142a (e)(2)(C)

2. Waiting period:

If the crime(s) I am asking the court to erase are:

- Misdemeanor conviction(s), I have not been convicted of any other crimes within 7 years of my last conviction; or
- Felony conviction(s), I have not been convicted of any other crimes within 10 years of my last conviction.

3. Sentence completion:

I have completed serving the sentence of imprisonment, including any type of parole, special parole, or transitional supervision, and any period of probation that I was sentenced to for:

- The crime(s) that I am asking the court to erase, and
- Any other crime that I was convicted of in state court on or after January 1, 2000.

4. Pending criminal charges:

I do not have any pending state criminal charge(s).

Therefore, I ask the court to erase the crime(s) listed above under Clean Slate.

I certify that the statements above and on any attached documents are true, complete, and correct to the best of my knowledge and belief. **I understand that if I have lied about the statements above or any of the information I have attached on purpose, I may have criminal charges filed against me.**

- Follow any standing criminal protective order; or
- Pay any fine that the court ordered you to pay as part of your sentence
