Issuance of a Firm Juris Number does not constitute registration of the law firm with or recognition of such law firm by the Judicial Branch. The terms "law firm" and "firm" as used in this form mean a legal entity whose primary purpose is to engage in the practice of law in Connecticut or elsewhere as that term is defined by Practice Book Section 2-44A. Firm juris numbers are issued per law firm, not per individual attorney, position, or office within that law firm. If a law firm has multiple locations in different cities, states, or countries each location may be issued a firm juris number. The attorney applying for a firm juris number must certify to the criteria in Section One in order for a firm juris number to be issued.

Firm Juris Numbers are issued only for the convenience of the CT licensed attorney(s) employed by the firm, and any information related to such Firm Juris Number may be changed at the request of the law firm, within its sole discretion, upon the completion of Section Two and submission of this form to the e-mail address below.
