**Application for Judgment of Possession:**

1. The plaintiff (landlord) and defendant (deceased tenant/occupant) agreed that the defendant (deceased tenant/occupant) would lease (rent) on a monthly basis or for a term, the premises (rental property) named above.

6. Based on the above, the plaintiff (landlord) asks this court for judgment for immediate possession of the premises.
