



The [Connecticut Supreme Court](#) will start its first term of the 2015-16 court year on Tuesday, Sept. 8, when it is scheduled to hear arguments in two cases. The first term will end on Friday, Sept. 18. All cases argued this term will occur at the [Supreme Court courtroom, 231 Capitol Ave., Hartford.](#)

The [2015-16 court year has eight terms](#), and [assignments for days and summaries](#) are posted on the Judicial Branch's website before a term begins. In addition, here are a few fast facts about the Supreme Court that may be useful:

- There is no time limit for the issuance of opinions. If you are following a case, please make sure to monitor the [Advance Release Opinions](#) webpage.
- The 2015-2016 court year goes from September through May. During each of the eight terms, the justices typically hear cases over a two-week period.
- The justices enter and leave the courtroom based on seniority. [Chief Justice Chase T. Rogers](#) enters and leaves first, followed by [Justice Richard N. Palmer](#), [Justice Peter T. Zarella](#), [Justice Dennis G. Eveleigh](#), [Justice Andrew J. McDonald](#), [Justice Carmen E. Espinosa](#) and [Justice Richard A. Robinson](#). Seating on the bench also is based on seniority. *Please note that if a justice is recused from a case, the order changes.*
