Instructions to Judgment Creditor

1. Fill out and give the original and 2 copies to the clerk to review and sign.
2. Attach a completed Subpoena (form JD-CL-43CO), if one is needed.
3. Give the original and 1 copy of the signed application to a proper officer for service (delivery).
4. Make a copy for your file.
5. The original application must be returned to court after it is served at least 6 days before the remote court hearing.
6. Appear remotely at the court hearing and be prepared to examine the judgment debtor on the debtor's property and the means of paying the judgment.
