**Instructions to Defendant**

  - If you are in prison now, you **must** also attach a completed Notice of Application form (JD-VS-3) to this application.
- Give the third copy to the State's Attorney for your case.
- Do not** use this form to ask the court for more jail credit.
- You do not need to get the State's Attorney's agreement and signature before you file this application.

**Instructions to Clerk**

- Do not accept** this form if the only relief requested is additional jail time or if an incarcerated defendant has not attached a completed Notice of Application form (JD-VS-3)
- Stamp form on filing. File original as a pending matter. Give the copy to the Presiding Judge.
- After Judgment:** Prepare copies of judgment, and distribute as follows:
  - Original and 1 copy to Centralized Court Services (for filing with original Information and under date of this order).
  - One copy to defendant or defendant's attorney.
  - If the defendant is incarcerated, 1 copy to the Records Office of the defendant's correctional facility.
  - If the defendant is placed on probation or the existing probation is modified, 1 copy to Adult Probation.
