Instructions:

1. If your spouse has not appeared, and you served your spouse in-hand (personally) or at your spouse's residence (abode), you may file this motion with the clerk no sooner than 30 days after the return date in your divorce (dissolution of marriage or civil union), or legal separation. For any other manner of service, you may file it no sooner than 60 days from the return date. There is no requirement that you file this form with the court if your spouse has not appeared. After 60 days have passed, if this form has not been filed, the court will schedule a hearing regardless of the manner of service.
2. You must also file a completed Financial Affidavit, form JD-FM-6 (LONG or SHORT) and an Affidavit Concerning Military Service, form JD-FM-178 in order for the court to proceed.
